


## **STR Regulations**

As of January 1, 2025, Port Sheldon Township requires registration of all properties operated as a short-term rental (STR defined as residence rented for not more than 29 days consecutively).

There are occupancy limits based on designated "off-street" parking spaces, and legal bedroom size. (not to exceed 16 occupants total)

## Short Term Rentals

Guide & FAQ





## Q: Can I rent my home, or a portion of my home as a short-term rental (STR)?

A: Yes, provided that you fill out the application to register with the township, pay the initial registration fee, and meet occupancy requirements.

### Q: How much does it cost to register a property as a STR?

A: The initial registration fee is \$350, and \$150 annually for each year you intend to rent. Payable by Jan 1, of the rental year

## Q: Can I rent the space in my Barn/Accessory building as an STR?

A: No, zoning ordinance does not allow for sleeping accommodations in accessory buildings, or more than one "dwelling unit" per parcel. (No ADU's, Granny Flats, etc.)

# Important Points

- "Short Term Rental" is defined as renting not more than 29 consecutive nights
- A local agent needs to be available On-Site within 30 minutes of being contacted by township or law enforcement officials
- The owner must consent to inspection of the STR upon request of township officials with 48 hours' notice
- The Township may revoke the rental registration if two (2) incidents resulting in violations of zoning ordinance or state law
- Notice of township rules, STR
   Ordinance, trash disposal, parking, and number of occupants must be provided to renters
- The exterior of the STR shall have a residential character, not incompatible with other dwellings in the vicinity, nor be altered to add excessive paved surfaces

### How many people can I rent to?

#### Sleeping Occupancy is set by room size

70 sq./ft. = 1 occupant

+50 sq/ft. for each additional room occupant

120 sq/ft. = 2 occupants 170 sq/ft = 3 occupants

\*Open floor plan - 2 occupants for each sleeper sofa allowed. (Max 2 sofas in separate rooms for a total of 4 occupants)

## Additionally, Unit Occupancy is limited by available off-street parking

2 spaces are required for 6 occupants (Minimum requirement)

1 additional space required for each additional 3 occupants

### **Total Unit Occupancy**

The maximum allowable occupancy is 16 occupants (aged 2 and up), but will be the lower number of the two calculations (room occupancy or off-street parking availability)
